LEGAL NOTICE OF PUBLIC HEARING ON THE BUDGET

NOTICE IS HEREBY GIVEN that the Proposed Budget of the Gibson Fire District #1 of the Town of Corning, State of New York, will be presented to the Board of Fire Commissioners of the Gibson Fire District #1, for its consideration.

A PUBLIC HEARING will be held at 7:00 p.m. at the Gibson Fire Hall, 2985 College Avenue, Corning, NY 14830, in the Hamlet of Gibson, State of New York on the 29th day of October 2019.

Pursuant to Town Law 105, the Board of Fire Commissioners must hold a public hearing on the budget, make the proposed budget available to the public prior to the public hearing, and allow the public to comment on the budget at the public hearing. This public hearing must be held to allow maximum public participation in the hearing.

The purpose of the public hearing is to allow any person to be heard in favor of or against the proposed budget as it is submitted, or for or against any item or items contained in the proposed budget, and hearing all persons interested in the subject concerning same.

Maple Street, Corning, NY 14830 and Fire District Secretary at 2889 Cowan Ave, Corning, NY 14830 where it may be inspected by any interested person during office hours (9:00 a.m. - 4:30 p.m. Monday – Thursday).
