**Resolution to Hold Public Hearing**

- 6) Motion to accept **Resolution 20 of 2026** to hold a public hearing on proposed **local law 1 of 2026** WHEREAS the Town Board of the Town of Corning has entered into a project for the codification of local laws, ordinances and certain resolutions of the Town of Corning for the purposes of increasing the effectiveness of town governmental administration, providing for greater public awareness of and access to town legislation and protecting the health, safety and welfare of town inhabitants; and  
WHEREAS the proposed codification has been published in loose-leaf form and the Town Board now desires to formally effect the adoption of said codification by enactment of a local law;  
NOW, THEREFORE, BE IT RESOLVED, that a public hearing be held by the Town Board with respect to enactment of the following local law, such public hearing to be held on the 16th day of June, 2026, at 7 p.m., in the Town Hall, Town of Corning, New York. The proposed local law to be considered is as follows:  
LOCAL LAW NO.01-2026  
A LOCAL LAW TO PROVIDE FOR THE CODIFICATION OF THE LOCAL LAWS, ORDINANCES AND CERTAIN RESOLUTIONS OF THE TOWN OF CORNING INTO A MUNICIPAL CODE TO BE DESIGNATED THE "CODE OF THE TOWN OF CORNING"  
Copies of the text of the above-named local law shall be filed in the office of the Town Clerk.  
AND BE IT FURTHER RESOLVED that the Town Clerk is hereby directed and authorized to cause public notice of said hearing to be given in accordance with the Municipal Home Rule Law, the Open Meetings Law and the Town Law of the State of New York.
